UPON ARRIVAL SPOKE TO F/S ASHLEY , WHO STATED THAT A WHITE MALE LEADING THE FOCUS GROUPS IN ROOM 62 FOR SODEXO RIPPED UP ONE OF THEIR SIGNS.</p> <p>PO KELSEY SPOKE TO MR ROBERT GRIFFIN THE DISTRICT MARKETING MANAGER FOR SODEXO WHO STATED, THE FIRST GROUP IN HIS MORNING SESSION WAS DISRUPTIVE AND HAD THEIR OWN AGENDA.
