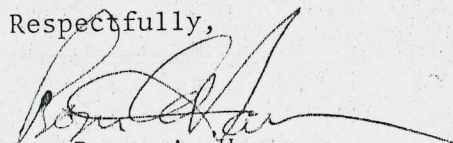
At approximately 11:00 AM this date, about thirty persons, led by Kent Ford, Tom Wilson, and Nate Proby, began a demonstration by picketing at Emanuel Hospital in protest of the pending eviction from the health clinic at 109 N. Russell. The demonstration was peaceful and orderly.

Sgt. Corbett and District 620 made frequent checks on the activity by driving through the area, but were not totally committed at any time, therefore no cost in expended man-hours can be accredited to this demonstration.

Picketing was terminated at approximately 1:30 PM, with no unusual incidents reported.

Sgt. Corbett obtained a copy of the attached brochure listing the above telephone numbers, among other things.

The police drove around Albina, arresting hundreds of young blacks. They brandished shotguns, called blacks by racist slurs that don't bear repetition, and tried to frame Black Panther Kent Ford on a charge of "riot."

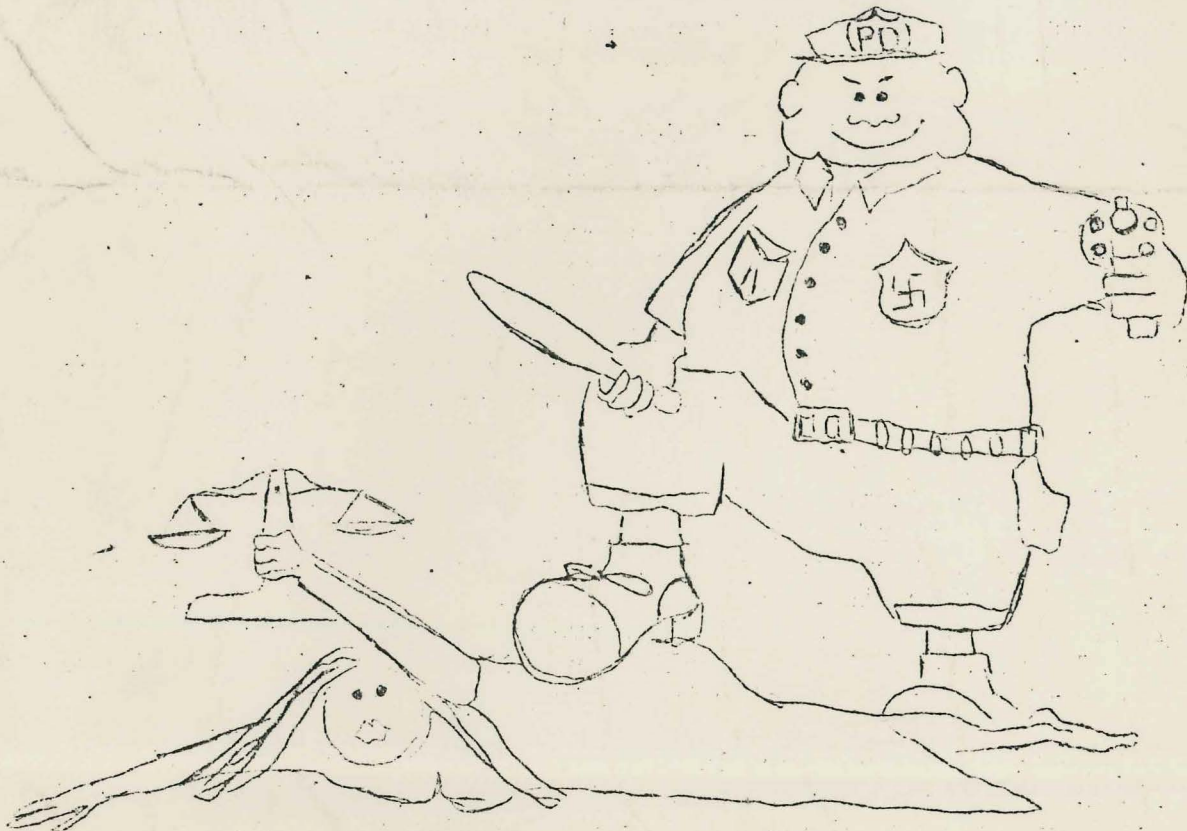

Come See About Albert

Albert Williams is Black - a 19 year old man charged with "Assault with Intent to Kill". His trial starts Tuesday, June 30, 1970 at 9:30 a.m. in the Multnomah County Courthouse. Albert Williams' plight and the events leading up to it, are the most recent in the on-going, ever escalating crisis between the Black community and the police force of Portland.



Last Feb. 18, Mr. Williams was standing outside the Black Panther Party headquarters in Albina when a police cruiser pulled up. The police, Stan Harmon and another officer, claim they recognized Mr. Williams and knew that a warrent was out for his arrest on a charge of "petty larceny" (the only warrent ever produced by the police was dated after Feb. 18th.) Mr. Williams went into the office and the police followed. What then happened is unclear. The police claim Mr. Williams fired at them with a rifle. Other witnesses claim his hands were in the air (in a sign of surrender) and he had no weapon when Officer Harmon shot him twice.

Why did this happen? Why does the Black Panther Party exist? Why is there greater and greater hostility between every police force and every Black community in this nation?

In the City of Portland, 5% of the population is Black, while only .8% (6 out of more than 700) of the police are Black. There are even fewer people of other racial origins. Who says racism isn't a problem in Portland?

It is well known that because of employment and housing discrimination, and racism in education, Black people are poorer, have fewer jobs, worse jobs, lower paying jobs, own less property and are concentrated in one section of the city - Albina. In Albina, the property - both residential and commercial - is mostly owned by whites who don't live there. This property is maintained to extract the greatest profit at the lowest cost.

In this property oriented society, one of the prime functions of the police is to protect property, even over life. During civil disorders, police are authorized to shoot people for stealing 6 packs of beer and cartons of cigarettes.

Finally every survey of police attitudes indicates a high degree of prejudice, fear, and hostility towards people of color.

The reasons are obvious - incidents such as the one involving Albert Williams and the police occur because white police with racist attitudes have been brutalizing Black people in defense of white property, white laws and white values all his life and long before. He has no reason to believe "the policeman is his friend". He has no reason to believe he would be treated fairly by white courts with juries made up of white people who have never been to Albina. Black people are more likely to be convicted, more likely to receive prison sentences, and receive longer sentences than Whites charged with the same crime. The poorer White people are, the more they get treated like Black people.

White America (White Portland) cannot expect to use white police with racist attitudes to enforce White laws and protect White property against Black people without causing trouble and violence. Slavery, lynchings, Medgar Evers, Martin Luther King, Fred Hampton, the 2 students in Jackson, the 6 people in Augusta, and Albert Williams are part of our history and society. How much longer will Whites be foolish enough to allow this dehumanization and violence against people of color to continue?

Much of what is true for Blacks is true in less degree for White youth and women. They are not respected, believed not capable of making decisions for themselves and powerless. The Chicago Conspiracy Trial, the Kent State 4 and the police riot at the Park Blocks indicate that White power and police will lash out just as violently to any threat or attempt at change. The history of workers being brutalized in strikes also indicates this. (The police said after the Park Blocks brutality, "It's an unpleasant part of my duty, but I just follow orders." That's what the Nazis said at Nuremburg.)

Violence against Black people, young people, working men and women can only lead to greater resistance and rebellion.

THE CASE

Last February, Sgt. Stanley Harmon shot and seriously 19 year old Albert Williams at the Black Panther Party Headquarters, 3619 N. E. Union. Harmon was officially seeking Williams on a two-month old warrant for petty larceny.

These are the details:

When Williams entered Black Panther Headquarters, Police reinforcements were called to surround the building. Williams was inside on a balcony with a rifle. Friends persuaded him to put the rifle down. Eyewitnesses have testified that Sgt. Harmon jumped up on a desk and shot Williams as Williams set the rifle down. Williams was shot through the arm and liver. When he was hit, the rifle discharged and the bullet hit the ceiling. Witnesses heard Harmon shout, "I got him! I finally got him!"

Instead of being taken to Emmanuel Hospital, a few blocks away, Williams was driven in the backseat of the squad car to Portland Adventist Hospital on 60th at Belmont. They refused to treat him and he was eventually taken to Multnomah County Hospital where he remained on the critical list for four days. He was charged with assault with intent to kill Harmon!

Years the black community has attempted to have Harmon transferred to another precinct because of his persistent brutality towards black people. Instead, Harmon has been promoted to detective duty in the black community.

The evidence clearly shows that Albert Williams is innocent of the charge. The charges should be dropped and punitive action taken against Harmon. The evidence also clearly shows that the attack on Albert Williams in the Panther Office is not just an isolated incident

INTIMIDATION

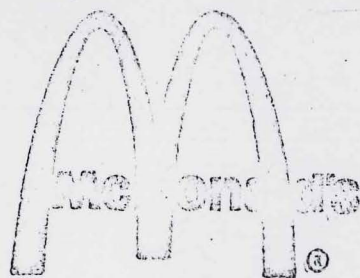
When United States Attorney Poole of San Francisco was fired, he observed that a national conspiracy does exist - a systematic program to "get" the Black Panther Party and its supporters.

National leaders of the BPP have been murdered (Fred Hampton in Chicago, Carl Hampton in Houston), held a year without trial (New York 21), railroaded into prison (Bobby Seale, Huey Newton), and driven into exile (Eldridge Cleaver). Party offices throughout the nation have been shot-up, children attending the breakfast program have been arrested, medical clinics have been attacked.

Why is there a systematic attack on the Black Panther Party? The Panthers have been a leading force in the black community for economic, political and social change. Through boycotts and education, they have shown the black community that the wealth it creates leaves the black community in the hands of white business. They have shown by example how black people can begin to build institutions that serve people rather than exploit them. They are pointing the way to freedom and they are pointing out those who stand in the way. The Black Panther Party is intolerable to those who have an interest in keeping the black community oppressed. The centers of economic power are also the centers of political decision making. And this is where the police and the courts come in: their version of "justice" means intimidation and oppression. Even if Albert Williams is acquitted, he has already spent eight months in prison. This mockery of law won't end until blacks and whites insist that they won't sit back and watch it happen.

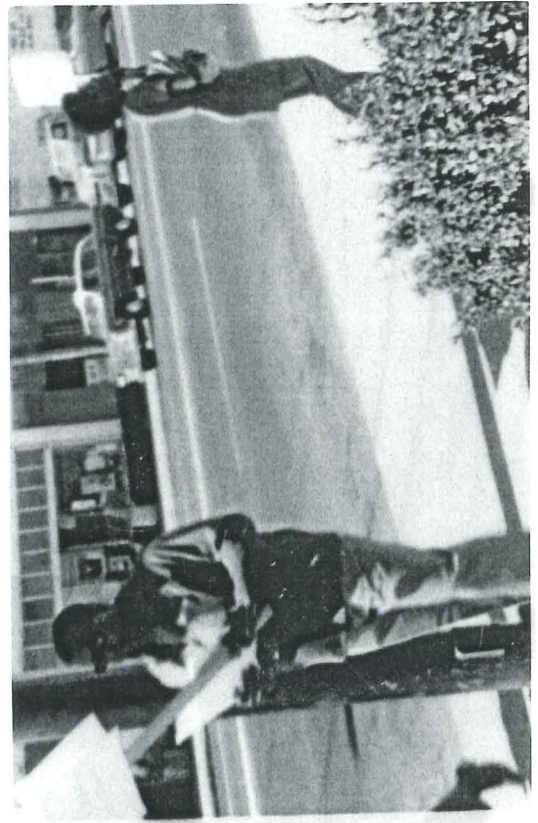

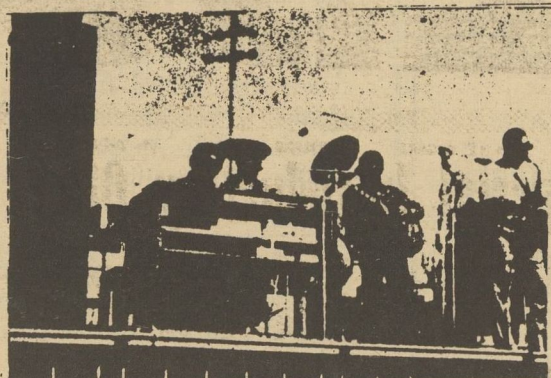

POCKET LAWYER OF LEGAL FIRST AID

1. If you are stopped and/or arrested by the police, you may remain silent; you do not have to answer any questions about alleged crimes, you should provide your name and address only if requested (although it is not absolutely clear that you must do so.) But then do so, and at all time remember the fifth amendment.

2. If a police officer is not in uniform, ask him to show his identification. He has no authority over you unless he properly identifies himself. Beware of persons posing as police officers. Always get his badge number and his name.

3. Police have no right to search your car or your home unless they have a search warrant, probable cause or your consent. They may conduct no exploratory search, that is, one for evidence of crime generally or for evidence of a crime unconnected with the one you are being questioned about. (Thus, a stop for an auto violation does not give the right to search the auto.) You are not required to consent to a search; therefore, you should not consent and should state clearly and unequivocally that you do not consent, in front of witnesses if possible. If you do not consent, the police will have the burden in court of showing probable cause. Arrest may be corrected later.

4. You may not resist arrest forcibly or by going limp, even if you are innocent. To do so is a separate crime of which you can be convicted even if you are acquitted of the original charge. Do not resist under any circumstances.

5. If you are stopped and/or arrested, the police may search you by patting you on the outside of your clothing. You can be stripped of your personal possessions. Do not carry anything that includes the name of your employer or friends.

6. Do not engage in "friendly" conversation with officers on the way to or at the station. Once you are arrested, there is a little likelihood that anything you say will get you released.

7. As soon as you have been booked, you have the right to complete at least two phone calls--one to a relative, friend or attorney, the other to a bail bondsman. If you can, call the Black Panther Party, and the Party will post bail if possible.

8. You must be allowed to hire and see an attorney immediately.

9. You do not have to give any statement to the police, nor do you have to sign any statement you might give them, and therefore you should not sign anything. Take the Fifth and Fourteenth Amendments, because you cannot be forced to testify against yourself.

10. You must be allowed to post bail in most cases, but you must be able to pay the bail bondsmen's fee. If you cannot pay the fee, you may ask the judge to release you from custody without bail or to lower your bail, but he does not have to do so.

11. The police must bring you into court or release you within 48 hours after your arrest (unless the time comes on a weekend or a holiday, and they must bring you before a judge the first day court is in session.)

12. If you do not have the money to hire an attorney, immediately ask the police to get you an attorney without charge.

13. If you have the money to hire a private attorney, but do not know of one, call the National Lawyers' Guild or the Multnomah County Bar Association and they will furnish you with the name of an attorney who practices criminal law.

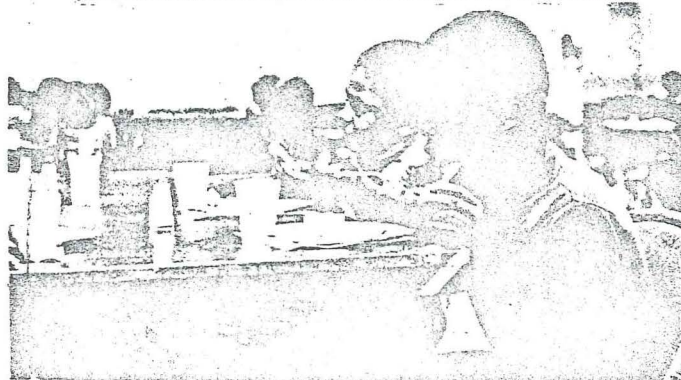

HUNGRY CHILDREN...

A Black child sits in a classroom and stares aimlessly out the window. The teacher talks about taking 14 apples and dividing them with 7 friends and ending up with 2 apples apiece. At the sound of the word apple, the Black child's face looks up and he seems to know what she's talking about, but he's thinking about how he can get one of those apples to eat. The teacher in the meantime drones on about remainders and quotients. The result is that the child falls farther and farther behind. The root cause of this problem is not mental incapacabilities or "cultural deprivation", but HUNGER.

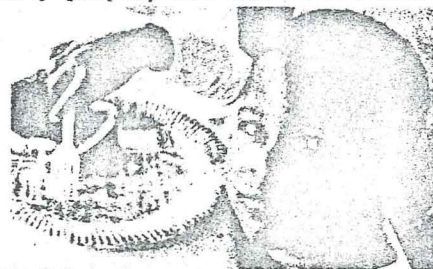
VICIOUS CHAIN...

It's a vicious circle that Black people are caught up in this country. They TELL US, You're hungry because you're poor...You're poor because you haven't got the best jobs.. You can't get the best jobs because you're uneducated, and you're uneducated because you didn't learn in school because you weren't interested. And every time the teacher mentioned 5 apple or 6 bananas, your stomach growled. How can a person learn about remainders and quotients when his mind is concentrating on a very real and concrete problem? Where is the next meal coming from? The Black Panther Party standing as a true representative of Black people's desires and needs, realizes that this vicious circle and chain of events must be broken, it cannot and must not be allowed to continue.



SERVE THE PEOPLE...

The Black Panther Party recognizes this vicious chain, and as our chairman, Bobby Seale says, "Revolutionaries must always go forth to answer the momentary desires and needs of the people, the poor and oppressed people, while waging the revolutionary struggle...We are concerned with the desires of the people and naturally the people are going to relate to what the Party is trying to put together for them. They will relate to the fact that the Party is really trying to serve them. We go down there to work, to put this program together. They become involved because they are community people, and there's not even



a preacher in any church (preachers have always brainwashed the Black people) who can deny a breakfast for children program. There's not a businessman nor a demagogic politician around who can deny a breakfast for children program and get away with it...

"A revolutionary organization has to maintain and righteously serve the people and not just give them. And when the people see that we're not giving they're going to relate to that. Because it's their program.

"As Huey has said, 'We are only like oxen to be ridden by the people. A strong detachment that the people can always use to serve them or when a crisis comes forth.'"

BREAK THE CHAIN!

The chain was broken: a free breakfast program was born in Oakland. The people under the leadership and guidance of the BLACK PANTHER PARTY smashed this evil chain, and moved to collectively feed their own children. Our party knew along with anyone else who had eyes to see and ears to listen, that our children were going hungry. But this is where our party differs from previous parties and groups. Our party took this basic desire and need of our people and brought it into reality working alongside the people.

FRED HAMPTON MEDICAL HEALTH CLINIC

The Peoples' Free Health Clinic has been functioning since 1969 as a community health service center. The service is free and available to anyone.

Since 1971, the Clinic has been told periodically by Emanuel Hospital, that it would have to move from its location at 109 N. Russell St.

We responded by saying that we were agreeable to the move, provided we were given adequate relocation.

After much negotiation, a lease was signed: 5 years rent free, for a building at Williams and Stanton.

It is just a shell, four walls and a roof that leaks. The only thing inside is a wall down the middle.

We were given the impression that because Emanuel had given us the building, the Portland Development Commission would give us the money for renovation. NOT TRUE!! We had been fooled again.

Now, After being served with a notice for immediate eviction, we are told by the president of Emanuel, that Emanuel has no money to complete the expansion project.

So why the rush to remove a clinic that is trying to provide a needed service to the community?

We are asking for adequate money to renovate our "new" building, and a promise that our present building will not be demolished until we can move into the new one.

We want Emanuel to live up to its responsibilities in this community. After all, we do aid Emanuel in treating people who are unable to pay for medical attention.
